This is to inform the general public including all districts, chiefdoms, clans, towns and villages adjoining the Forest Applicant Communities in River Gee County, otherwise known as; Kiteabo Chiefdom Community and Chedepo that the Forestry Development Authority (FDA) has approved the applications of these communities to begin the process of acquiring a Community Forest Management Status in keeping with the Community Rights Law (CRL) and the Community Rights Law regulations. The notice will be posted for a period of thirty days beginning from January 18, 2016 to February 18, 2016. The notice will be posted in all public places in every towns and villages of these applicant communities and adjacent communities for a period of thirty days. After the 30 days' notice, the FDA will work with each community to find a suitable date and time for the CONDUCT DEMARICATION AND MAPPING SURVEY in each community to further verified the information provided in the application letters and also to learn about the communities' way of life.

Therefore, every member of the above communities are encouraged to please check at every public places to view the notice. The notice contain phone numbers of both the community representative and the FDA that could be used to seek any clarification about the process. Meanwhile, all adjacent communities and community members in the areas where the Posting of 30 days Demarcation Notice will take place are encouraged to please take note and cooperate with the FDA.
