

Therefore, every member of the above communities is encouraged to please check at all public places to view the result.


Meanwhile, all adjacent communities and community members in the areas where the Posting of the results will take place are encouraged to please take note and cooperate with the FDA.

OVERVIEW

On February 23, 2022, Mr. Tamba Brown, GIS Technican travelled from Monrovia to Zwedru, Grand Gedeh County for the posting of results from the Social Economic Survey and Resource Reconnaissance (SESRR) and Preliminary Demarcation Maps under Chapter 2, Section 2.9 of the CRL Regulation.

February 24, 2022, the team visited the Regional Forester and staffs at the Regional Office. The purpose of his visit was to give briefing of his mission and planned with field staffs to conduct the posting in Tchien Menyen Community Forest. On the same date, the Regional Extension Officer R 4, escorted Mr. Brown to meet the Hon. County Superintendent for briefing and delivered the Letter from MD/FDA explaining the posting. The copy of the MD/FDA was verified at the back to show that he received the Letter.

The chairman for Tchien-Menyen Community Forest, Mr. Eric W. Glay, also visited the Smile FM Radio 98.6 MHZ to create 30 days Announcement Airing and receipt verified.

ACTIVITIES

The team members Mr. Cyril T. Brown GIS, Moses Kolubah REO, and Chris Yelleh NRMO, visited the community to arrange a meeting for the 27th of February for the posting exercises.

On the 27th of February, the community meeting was held in Suah Community with 33 participants in attendance. Due to the death of one of their relatives, women were not represented.

FDA field staffs explained the SESRR and Preliminary Demarcation Maps that took placed last year in their communities meetings. Key questions were asked and the team answers in details especially the maps that has 48,365 hectares. They were also informed that after the 30 days notice without compliant, the community can go for election.

At the end of the Community meeting, the Chairman T.M.C.F. received the Copies of the SESRR and Preliminary Demarcation maps and signed each attesting that the community leaders received the documents for the 30 days posting to inform members of the applicant and adjacent communities.

Posting were done by the regional staffs in Konobo and Cavala districts head quarters where again the team explained in details about the 30 days notice. The two Commissioners thanked the team and said that the awareness will be created.
