Dear Mr. Glay:

The Management of the Forestry Development Authority (FDA) presents compliments and seizes this opportunity to acknowledge receipt of your communication dated April 13, 2022, in which you expressed your communities' readiness for election of its Governance Structure.

Now that the results of the Socio-Economic Survey and Resource Reconnaissance, the Demarcation and Mapping have been posted in and around your proposed community forest, and no objection has yet been raised, your community is authorized to form the necessary community forest governance institutions, which are mandated under the Regulations to the Community Rights Law of 2009 with respect to Forest Lands (CRL Regulations).

These consist of Community Assembly (CA), the highest oversight and decision-making body of the forest community with its Executive Committee (EC) and Community Forest Management Body (CFMB), which will be responsible for the day to day management and oversight of the community forest.

The FDA will work to assist you in this process so that you can form your community Assembly and CFMB as quickly as possible and in conformity with the legal requirements established in the CRL Regulations. Once this has been achieved, the FDA will work with you to develop, review and sign a Community Forest Management Agreement, and begin to draft a community forest management plan to manage your forest resources.

Accordingly, a technical team from the FDA headed by Moses Kolubah Regional Extension Officer, alongside with the following: Chris G. Yelleh, James M. Borbor and Korlu Gorvov assigned in Grand Gedeh will be conducting these elections in Tchien Menyem Community, Grand Gedeh County from May 10-13, 2022.

Your presence during these exercises will be highly appreciated.



Introduction

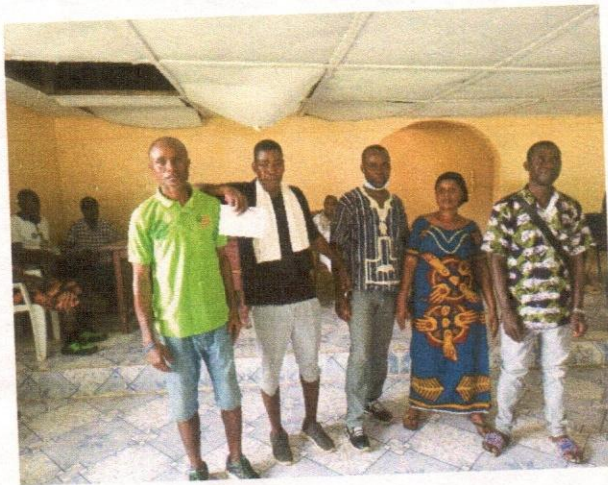
This report under review covers activities marking the conduct of elections in Tchien Manyan Community Forest, Tchien Manyan Section, Tchien District, Grand Gedeh County. According to the Community Right Law Regulation of 2011 (chapter 3 section 1,3,4 and 7) power to lead and govern an authorized forest community shall be through the establishment of a Community Assembly (C A). The Community Assembly shall be the highest decision-making body of the community with respect to community forest.

After successfully completing of step 7 (30 days notices were posted for elapsed without any objection/conflict), the Tchien Manyan Community Forest informed the Authority of the readiness for step 8 (setting up of their governance structures). A massive awareness was conducted in the towns and villages for the elections of CA and CFMB from the affected Communities by the FDA field staff of the Community Forest Department assigned in region 4 Grand Gedeh County, the Civil Society Organization and Stakeholders. During the awareness process, the governance structures (Community Assembly, Executive Committee and the Community Forest Management Body) roles and responsibilities were explained to the community people from the thirty-six (36) affected communities. Two representatives from each community to the assembly. They are as follows:

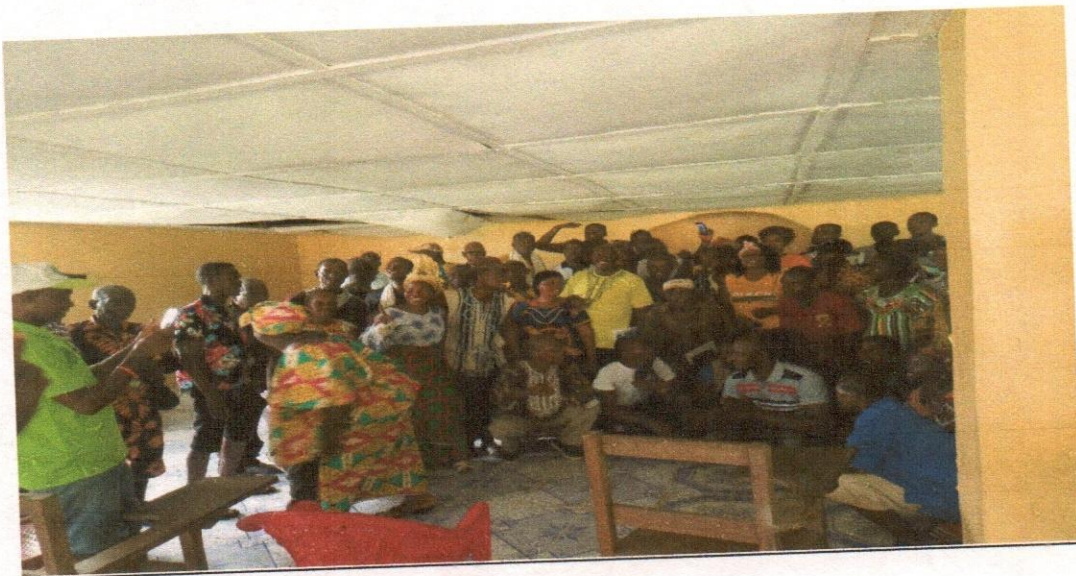
