

Forestry Development Authority (FDA) Vacancies Announcement

The Forestry Development Authority (FDA) is a Public Corporation of the Republic of Liberia created by an Act of Legislation in 1976. The Act empowers the FDA to, among other things, sustainably manage the Forest and related resources of the Republic for present and future generations.

In an effort to achieve its goals and objectives, the FDA is sub-divided into *Administration, Forest and Wildlife Conservation, Community Forestry, Commercial Forestry, Research and Development, Legality Verification, Licensing and Carbon Harvesting*.

Recently, the Government of Liberia through the Civil Service Agency and the Forestry Development Authority (FDA) initiated retirement exercises, with the end date of 31st October 2024, of staff members who had attained the age of sixty (60) years or above.

These retirement exercises have created vacancies which the FDA Management Team has resolved to fill through competitive recruitment processes.

Consequently, the Forestry Development Authority (FDA) is soliciting applications and resumes from qualified and passionate Liberians for the below listed positions on or before the close of business 10th October 2024 at 4: 30 P.M. Please be aware that most of the jobs are field based and required many hours of work in the forest as well as living in rural areas near duty stations.

Kindly note that only short listed applicants will be contacted for testing and/or interview. Short listed applicants must be in possession of valid national identification cards and original copies of academic credentials for presentation upon request.

To address gender disparity in Forest Sector jobs, preferences shall be given to successful female applicants that are equally qualified.
